## Model Ranks Number One As Heptathlete

ASU Junior Gea Johnson, an admitted stress maniac and perfectionist, likes to model clothes; but her passion is Track and Field and she currently ranks number one in the nation in the heptathlon with 6,129 points. Her first two years as a Sun Devil were not happy with the mid-season firing of head coach Clyde Duncan and the problems that came out of that situation. Personally, the controversy and confusion dropped her confidence level and some people called her overrated. But since last April, she has regained her confidence and found she could break the 6000 point level. Her accomplishments thus far include:

- Score 6,129 points - school, stadium and PAC-10 record and the third highest collegiate total ever.
- Set school and stadium records in the 100-Meter Hurdles (13.70 seconds)
- Set school and stadium records in the High Jump (5'10½")
- Set school and stadium records in the Shot Put (44' 2")
- Set school and stadium records in the Long Jump (20' 6½")
- Set stadium record in the 800M Run (2:17.57)
- Set school and stadium records for first day point total (3,652)
- Set school and stadium records for second day total (2,477)

Gea will next compete in the May PAC-10 Championships in Seattle. After that, she has her sights set on the 1992 Olympics in Barcelona, Spain. She will work hard for those Olympics but believes she will realistically peak for the 1996 Games.

An "A" student, Johnson thinks she would like to model clothes for money once she graduates which would help finance her Olympics dream. She credits her mother, Sally, with the necessary support system responsible for regaining her confidence.



## Parking Changes at ASU

All parking on the ASU Campus is regulated by the Parking Services Division of the University. It is their job to provide parking for students, faculty, staff, and all campus visitors. They are responsible for the maintenance and upkeep of all parking lots and structures as well as the administration and sale of parking spaces to University related people. Parking Services is totally funded through the rental of parking spaces to students, faculty, staff, and administration, meter money and revenues derived from the payment of tickets issued for parking violations.

In March of 1989, the Board of Regents approved a five year parking plan for parking fees through 1993-94. The first increase is effective this year and affects Sun Angel

members with regard to the football season. The increase of \$2 per game makes a total of \$5 per home game or a total, for the 1990 season, of \$30. The SAF will continue to pay the original parking fee of \$3 per game, which comes out of SAF membership fees, but the increase of \$12 per season was billed to each parking member along with their annual renewal notice. The plan stipulates that the \$5 per game fee will remain constant through the 1991 season, but will be increased to \$7 per game beginning in 1992.
